LETTER OF INTEREST

regarding the application for funding under the INTERREG EUROPE 2021-2027 Programme, as a partner

The Prefect's Institution - Brăila County is led by the prefect, who is the representative of the Romanian Government in Brăila County and has the powers provided for in the Emergency Ordinance no. 57 of July 3, 2019 regarding the Administrative Code, as well as in other laws.

The prefect's categories of duties are:

- attributions regarding ensuring the implementation of government policies at the local level and respect for public order;

Our project idea is:

Digitization of the flow of documents in the organization

In the course of the current activity of our institution, which has an institutional connection with many and various stakeholders (ministries, government agencies, administrative-territorial units, non-profit organizations, citizens, etc.), a large part of information is received, used, created and generated and various amount of documents. This means consuming a lot of paper, a lot of ink, a lot of physical storage space and, by implication, a longer time to find a document in the archive.

As a result, through this project we aim to carry out exchanges of experience, visits to organizations where the flow of documents is digitized (from the entry of a document into the institution to the sending of the response and its archiving) and other activities proposed by the other partners, in order to fulfill our objective .

Following the implementation of this project, our institution will try to digitize the flow of documents through a project financed through an operational program, which will lead both to the "greening" of the activity and to the reduction of the response time to stakeholders.
